

Redirection of Net Revenues

Under the Dartmouth College Policy on Patents, Copyrights and Other Intellectual Property (the "Policy"¹) Authors, Creators and Inventors are entitled to share in 50% of the Net Revenues received by the College under licenses or certain other agreements with third parties pertaining to Inventions, Works of Authorship and other Intellectual Property, as specified in the Policy.

I understand that I am entitled to a share of the Net Revenues payable under the license or other agreement identified below (the "Applicable Agreement"). By executing this Redirection of Net Revenues (this "Redirection"), on behalf of myself and my heirs, successors and assigns, I (i) waive the distribution of Net Revenues to me, on a revocable or irrevocable basis as provided below, (ii) assign my right, title and interest to such Net Revenues to the College, and (iii) direct the College to distribute them, as provided below. I (i) represent and warrant to the College that I have full power and authority to execute and deliver this Redirection and that the assignment and instructions provided below do not, and will not, constitute a violation or breach of any obligation I have under applicable law or to any third party, (ii) acknowledge that the College may amend the Applicable Agreement from time to time as it determines in its sole discretion and is not obligated to notify me of any amendments, and (iii) agree that this Redirection shall be governed by the laws of the State of New Hampshire without regard to its conflicts of law provisions.
